## VENDOR FORM INSTRUCTIONS AND GUIDELINES

A **vendor/artist** is someone that solely sells their wares at the festival. This includes all foods, beverages handmade crafts/art and quality manufactured items. \$50.00 VENDOR FEE FOR ONE 10' x 10' SPACE (An Early Bird Discount is available for those registering prior to July 15, 2016).

An **interactive exhibit** is where the artist provides an activity for the public to participate in, hands-on art activities where the participant may walk away with the art they created. NO VENDOR FEE FOR ONE 10' X 10' SPACE AND THE ARTIST MAY CHARGE A FEE IF THE PARTICIPANT CAN WALK AWAY WITH A PIECE OF ART THAT THEY THEMSELVES CREATED.

ANY VENDOR/ARTIST THAT REQUIRES ELECTRICITY OR WATER WILL BE CHARGED \$5 EACH PER DAY (Limited Outlets are Available - Plan Accordingly)

- All art sold must be hand made in the United States and represent quality craftsmanship.
- All vendors must provide their own table and chair (tables can be rented for \$5.00)
- Every vendor must have a visible sign on their booth that defines who they are.
- Food Vendors must be licensed to sell and meet Pennsylvania State HACCP requirements.
- Alcohol sales for tasting booths are allowable with appropriate permits.
- Not for Profit 501C3's wishing to participate in Art Blast will not be charged a vendor fee for a space. The application must be returned with their IRS designation form attached.
- Set-up begins at 8:00 AM on Saturday and 10:00 AM on Sunday.
- *Nathanael Greene would appreciate a donation of a piece of your work for a Raffle Basket.*
- *Security will be provided for Saturday night*
- *NO FLEA MARKET SET UPS*
- *Cars must be removed before set up to the back lot of the Ice Plant.*
- *We plan all the vendors to be under our tents but if needed you may be asked to bring your own tent*
- *No exit from the Craft Area before 5 PM on Saturday and 4 PM on Sunday*
- *If you are unable to attend your fee will Not be refunded.*
- *You will receive confirmation of your acceptance. If for any reason, you are not accepted, your application and check will be returned to you.*
